- **What: 8 or 4-mile Open Ocean Paddleboard and Stand Up Paddle race**
- **Where: Start and finish on the beach at the Oceanside Pier area.**
- **When: Saturday August 8<sup>th</sup>, 2009, 8:30am Start**
- **Entry Fee:** \$35.00 up to May 29<sup>th</sup>, \$40 up to June 26<sup>th</sup>, \$45 up to July 28<sup>th</sup>, \$55 race day.

I WAIVE, RELEASE, AND DISCHARGE from any and all claims, losses or liabilities for death, personal injury, partial or permanent disability, property damage, medical or hospital bills, theft, or damage of any kind, including economic losses, which may in the future arise out of or relate to my participation in the event(s) discussed above or racing activities, the City of Oceanside, State of California, NA Multisports, and all agents, officers, sponsors, and related staff. THIS RELEASE INCLUDES CLAIMS, LOSSES, OR LIABILITIES ARE CAUSED OR CLAIMED TO BE THE RESULT OF THE NEGLIGENT ACTS OR OMISSIONS OF THE PERSONS I AM RELEASING OR ARE CAUSED BY THE NEGLIGENT ACTS OR OMISSIONS OF ANY OTHER PERSON OR ENTITY. I assume the risks of running, swimming, paddling or participation in any racing event. I also assume any and all other risks associated with the event or racing activities, including but not limited to falls, or effect of any other participants, effects of weather, including heat and/or humidity, surf conditions, marine life, water temperature, defective equipment, the condition the running surface, water hazards, contact with other swimmers or runners, and any hazard that may be posed by vehicular traffic or pedestrians, all such risk being known and appreciated by me. I further acknowledge that these risks include risks that may be the result of the negligence of the persons released herein. I agree to indemnify and hold harmless the persons released herein from any and all claims made or liabilities assessed against them as a result of my actions or inactions related to the above event(s).

### **WAIVER, RELEASE OF LIABILITY, AND ASSUMPTION OF RISK**

In consideration of the services of NA Multisports, its member clubs, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as ("NAM")), I hereby agree to release, indemnify, and discharge **NAM** of liability, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as described below with respect to **NAM** activities, including but not limited to **NAM** races, fundraising events, community outreach events, practice and preparation for those races and events, at any location including but not limited to any location where such race or event occurs or where equipment for those races and/or events is placed or is in use.

1. I acknowledge that my participation in open water swim, beach running and paddling a paddle board or stand up board entails risks that are known, unknown, anticipated, and/or unanticipated that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks cannot be eliminated without jeopardizing the essential and/or fundamental qualities of the activity. I assume those risks and release **NAM** of liability resulting from those risks. I understand that I am hereby relinquishing certain legal rights.

**The risks include, among other things:** vessel capsizes; tidal conditions and currents; travel in remote areas; collision with objects or other watercraft; prolonged exposure to cold water, hypothermia, accidental drowning; illness in remote areas; exposure to sun, strong wind, cold, storms, large waves, eddies and whirlpools; lightning; aggressive and/or poisonous marine life; wrist, arm, shoulder, and/or back injuries; slips and falls, including those occurring while getting on and off the vessel; and rapidly changing adverse weather and water conditions. Furthermore, I understand that **NAM** seeks safety, but it is not infallible, it might be unaware of a participant's fitness or abilities, it might misjudge the weather, the elements, or the terrain, and that it may give inadequate warnings or instructions. I also understand that the equipment being used might malfunction. I expressly acknowledge, and promise to accept and assume all of these risks.

2. I acknowledge, agree, and represent that I understand the nature of open water swimming, running, paddle board and SUP paddling and that I am qualified, in good health, and in proper physical condition to participate in such activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the activity.

3. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.

4. **This agreement applies to any negligence alleged against NAM:** I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless **NAM** from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of **NAM**'s equipment or facilities, including any claims which allege negligent acts or omissions by **NAM**.

5. Should **NAM** or anyone acting on its behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.

6. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.

7. In the event that I file a lawsuit against **NAM**, I agree to do so solely in the state of California, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

**By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against NAM on the basis of any claim from which I have released them herein. I have had sufficient opportunity to read this entire document. I have read and understand it, and I agree to be bound by its terms.**
